



TV21 Dealer Registration

On the weekend of Friday 22nd to Sunday 24th October 2010 Fanderson will be staging their first major convention for four years. TV21: Adventure in the 21st Century will celebrate the fact that this year Thunderbirds will be 45 years old, UFO will be 40 and Space:1999 a mere 35.

TV21: Adventure in the 21st Century will be held at the Ramada Bristol City [<http://www.ramadajarvis.co.uk/hotels/bristol.aspx>] which is just 5 minutes' drive from the M32 which links to the M4 and from there to the M5, providing easy driving access to all compass points. The hotel has good parking for vans and is just five minutes walk from Bristol Temple Meads station.

As well as features (where interviews and special screenings will take place), an exhibition (of models, puppets, costumes and artwork), discussion panels, guest appearances and autographs, we've set aside a room for a limited number of Dealers selling items that will be of interest to our delegates. Tables in this room are a nominal 6'x2' and cost £150 each for Friday afternoon and Saturday, or £100 for Saturday or Sunday. Each table booked includes entry for one member of staff to man the table, but does not give access to the convention proper. We are intending to open the con (and the dealers room) from lunchtime on the Friday. Further details of the event can be found on the con webpage [tv21.weebly.com].
